# **About Summergil House School**

Summergil House is an independent special school situated near the Powys and Herefordshire border in Presteigne. The school opened in March 2017 and is part of the Orbis Education and Care group.

The school provides education for pupils aged 5 to 19 years who have a diagnosis of autistic spectrum disorder. Nearly all pupils have a statement of educational needs.

Currently, there are nine pupils attending the school, seven boys and two girls. Many pupils are placed by local authorities in England and the remainder from Wales. Nearly all pupils have English as their first language.

Many pupils reside at the registered on-site children's home.

The head of education was appointed in May 2017. The school has two class teachers and three learning support assistants. A clinical team, including a speech and language therapist, behaviour specialist and occupational therapist, supports the education team.

The school's aim is to 'provide a safe and secure school environment that encourages individuality, confidence and self-esteem'.

# **Main findings**

### Strengths

Since opening, the school has taken great care to plan the individual transition of each pupil. As a result, this has helped reduce pupil anxiety in settling into their new school. Pupils have positive attitudes to their learning, enjoy their lessons and engage positively with learning activities.

The school benefits from a rural location and provides a stimulating learning environment. An extensive outdoor area provides good opportunities for pupils to gain an appreciation of nature and the environment in which they live.

Pupils benefit from a broad range of therapeutic inputs provided by the school. Specialist staff work well with school staff, and as a result pupils have a strong sense of wellbeing.

The school has appropriate systems in place to track both the academic and social needs of all pupils. As a result, staff know their pupils very well, and respond swiftly to both their wellbeing and learning needs.

The school has appropriate policies in place to guide the work of the school, including useful pupil friendly versions, where appropriate. Leaders at the school are enthusiastic and have a clear sense of purpose.

The school meets all of the Independent School Standards (Wales) Regulations 2003.

#### Recommended areas for action

Strengthen policies to ensure that they reflect the latest Welsh Government guidance and are appropriate to the context of the school.

Improve reports to parents to include more detail about what pupils have achieved and how they can move their learning on.

Ensure quality assurance processes focus on the standards achieved and the progress made by pupils.
